

Textile Project Fee Structure 认证费率表

This document describes the methods and rules for the quotation of Textile Exchange certification, with the aim of ensuring the uniformity and fairness of the quotation mechanism

说明Note:

1	差旅费：按照客户要求实报实销或预估 Travel Cost: reimbursement on an actual or estimated basis in accordance with the client's requirements
2	更名：组织的法律主体未发生变化，相关的统一信用代码和成立时间未发生变化，仅进行了工商注册名称的变化，收取服务费200元/次。 Organization Name Change: The legal entity of the organization remains unchanged, and the relevant Unified Social Credit Identifier and establishment date also remain unchanged. Only the name registered in the Municipal Bureau of Administrative Services has been changed. The service fee is CNY 200.00 per change.
3	更址：①组织实际地址未发生变化，仅门牌号发生变化，费用收取同更名，200元/次；②组织实际地址发生变化，需执行跟进审核，收取标准报价的50%。 Organization Address Change: ① If the actual address of the organization remains unchanged and only the house number has changed, the fee charged is the same as that for name change, which is CNY 200.00 per time. ② If the actual address of the organization has changed, a follow-up audit needs to be carried out, and 50% of the standard quotation will be charged.
4	认证报价含税，税费=（认证报价+差旅费）*现行税率 The Certificate fees are tax inclusive, TAX = (certified offer + travel costs)*Current VAT Rate
5	For companies that include trading site, in principle, for the trading part that meets the remote audit requirements in accordance with the standard requirements, remote audits shall be implemented. In special circumstances, if it is evaluated that the risks are relatively high or the client requests an on-site audit, on-site audits shall be implemented. 6	①For the quotation of audits combining multiple standards, it shall be calculated as the price of the factory type with the higher level + 6,500 * N. 多标准结合审核报价规则按照较高类型工厂价格+6500*N计算。 ②For applications for any one or more standards in RAF, the quotation is uniformly 8,000 yuan. The prices for joint certification and multi-site certification remain unchanged. 申请RAF中的任意一个或多个标准，均报价8000元，联合认证和多场所价格维持不变。 ③During the validity period of an SC certificate, if a follow-up audit is required due to changes that necessitate an on-site audit, the fee shall be charged at 50% of the standard quotation per occurrence. SC证书一个周期有效期内需执行现场审核的变更需执行跟进审核的，按照标准报价的50%收取/次。

The cost of trade certificate is calculated according to the number of trade certificate actually applied by the certified enterprise, which is not included in the annual certification fee.
