1. Scope/范围

This procedure sets forth the basic principles and impartiality commitment followed by ASCP in the implementation of audit and Sustainable Textile certification services, and makes clear provisions for ASCP organizations to ensure compliance with all relevant certification requirements. /本程序阐述了 ASCP 在实施纺织品认证审核和可持续认证服务时所遵循的基本原则和公正承诺，并为 ASCP 组织确保符合所有相关认证要求作出了明确规定。

This procedure is an integral part of ASCP contractual agreement for both Better Cotton Chain of Custody Standard certification scheme. /本程序是 ASCP 的良好棉花监管链标准认证计划合同协议的组成部分。


- Better Cotton, a global not-for-profit organization, is the largest cotton sustainability programme in the world. its mission is to help cotton communities survive and thrive while protecting and restoring the environment, delivering progressive, measurable change for the better at field level, in line with the 2030 Sustainable Development Goals (SDGs). Better Cotton is a joint effort, working together with organizations from farms to suppliers, manufacturers, and brands, to transform cotton production worldwide, building on Better Cotton's status as a sustainable mainstream commodity in order to deepen impact./Better Cotton 是一个全球性的非营利组织，也是世界上最大的棉花可持续发展计划。其使命是帮助棉花种植社区在保护和恢复环境的同时生存和发展，并根据2030年可持续发展目标（SDGs），在田间层面实现渐进的、可衡量的积极变化。良好棉花是一项共同努力，与从农场到供应商、制造商和品牌的各类组织合作，以转变全球棉花生产。他们基于良好棉花作为可持续主流商品的地位，将进一步深化其影响。

Audit/审核: An evaluation undertaken by a certification body to verify conformity with a Standard.

It may be conducted on-site or remotely and may involve visual inspection, interviews and/or document reviews./ 认证机构为验证是否符合某一标准而进行的评价。审核可以在现场进行，也可以远程进行，还可能包括目视检查、面谈和/或文件审查。

Auditor/审核员: A certification body representative who conducts audits./进行审核的认证机构代表人员

Certification Body/认证机构: An accredited third-party carrying out auditing and certification in accordance with the provisions set out in the applicable Standard and the ACP. An accredited certification body may issue scope certificates and transaction certificates./ 获认可的第三方根据适用的标准及核心计划所载的条文进行审核及认证。经认可的认证机构可以颁发范围证书和交易证书。

Certification/认证: A status awarded by a third-party certification body to a producer, supply chain company or retail brand to confirm their compliance with the relevant Better Cotton Standard and requirements has been confirmed. This certification status, together with other Better Cotton registration/ approval steps as relevant, gives the producer, supply chain company or retail brand the right to trade Better Cotton and/or make Better Cotton claims./由第三方认证机构授予生产者、供应链公司或零售品牌的一种状态，以确认其符合相关的 Better Cotton 标准和要求。这种认证状态，连同其他相关的 Better Cotton 注册/批准步骤，赋予了生产者、供应链公司或零售品牌交易 Better Cotton 和/或提出 Better Cotton 声明的权利。

Non-conformity/ 不符合项: A gap identified in compliance with a clause/ indicator of a Better Cotton Standard./在遵守 Better Cotton 标准的某一条款或指标时所识别出的差距。


Certified Organization/认证组织: An organization which holds a scope certificate./持有范围证书的组织。

Organization/组织: A legal entity which is certified to or in the process of becoming certified to a Standard. 已达到或正在达到某一标准的法定实体。

Surveillance audit/监督审核: All auditing activities carried out by the Certification Body that take place between the full audits of initial certification and certification renewal./由认证机构在初次认证和认证更新的全面审核之间执行的所有审核活动。

Cancellation of certification/取消认证: When a producer or a supply chain actor voluntarily stops their certification or has become ineligible./当生产者或供应链中的一个参与者自愿停止认证，或者不再符合资格时。

Suspension of certification/ 暂停认证: A valid certificate is in place but for a period of this certificate the certification status is suspended by the Certification Body pending certain conditions being met which will lift the suspension. During the suspension the ability to trade Better Cotton or

make Better Cotton claims is withheld. The certificate expiry date remains unchanged. Surveillance and corrective action activities are still required during the suspension period./有效的证书已经到位，但在该证书的某个期间内，由于某些条件未满足，认证状态被认证机构暂停。在暂停期间，交易良好棉花或提出良好棉花声明的能力将被暂时取消。证书的有效期保持不变。即使在暂停期间，仍需要进行监督和纠正措施活动。

Withdrawal of certification/ 撤销认证 : When a producer or CoC organization has their certification withdrawn by a certification body as a penalty due to the conditions of a suspension not having been met or other situations defined in the P&C or CoC monitoring and certification requirements. Right to trade Better Cotton or make Better Cotton claims is withdrawn and a full new application for certification is required. This may only be possible after a certain period of time has passed as defined in the P&C or CoC monitoring and certification requirements./当生产者或 CoC 组织因未能满足暂停条件，或未能遵守 P&C 或 CoC 监控和认证要求中定义的其他情况，而被认证机构处罚撤销认证时，其交易 Better Cotton 或提出 Better Cotton 声明的权利将被取消，同时需要重新申请完整的新认证。根据 P&C 或 CoC 监控和认证要求的规定，这种重新申请可能仅在经过特定时间后才可进行。

4. General Requirements/一般要求

4.1 Legal and contractual matters/法律及合约事宜


4.1.1 Certification agreement/认证协议

ASCP signs a legally binding certification agreement with all its customers, which is formulated in accordance with the relevant requirements of ISO17065 and General Certification Requirements for Certification Bodies. This procedure is an integral part of the contractual agreement between ASCP and each customer for Better Cotton Chain of Custody Standard./ ASCP根据 ISO17065 的相关要求和认证机构通用认证要求，与所有组织签订了具有法律约束力的认证协议。此程序是 ASCP与组织之间关于良好棉花监管链标准的合同协议的组成部分。

The customer shall sign the agreement to contract demonstrate its commitment to comply with the requirements of the relevant certification scheme. ASCP will not be in a position to offer any certification services prior to the agreement being signed by both parties./ 组织须签署合约协议，以显示其遵守有关认证计划要求的承诺。在双方签署本协议之前， ASCP无法提供任何认证服务。

The agreement can be terminated as follow: /本协议终止方式如下：

- ASCP's customer has the right to withdraw from the certification agreement through formal written notification with at least 30 days notification./ ASCP的客户有权在 30 天内以正式书面形式通知撤销认证协议。

- ASCP reserves the right to terminate the certification agreement for failure to pay the agreed certification fees or if the organization fails to comply with the certification requirements as outlined in this document./ ASCP保留终止认证协议的权利，如果该组织未能支付约定的认证费用或未能遵守本文件中概述的认证要求。

ASCP specifically requires its customers to keep records of all complaints related to certification requirements and provide these records to ASCP./ ASCP特别要求组织保存所有与认证要求有关的投诉记录，并将这些记录提供给 ASCP。

During the audit, the customer complaint records are regularly checked./ 在审核过程中，定期检查组织投诉记录。

4.1.2 Management of Impartiality/公正性管理

In compliance with ISO 17065 requirements, ASCP is committed to provide impartial certification services while managing any potential conflict of interest. ASCP has implemented procedures that do not discriminate or limit access to certification. ASCP's services are open to all applicants whose activities are within the scope of ASCP's operations. ASCP does not restrict the implementation of certification to the size of the customer, the membership of an association or body, or the number of certificates already issued. Top management makes the following commitment to impartiality in certification service: / 遵照 ISO 17065 的要求，ASCP致力于提供公正的认证服务，同时管理任何潜在的利益冲突。ASCP实施了不歧视或限制获得认证的程序。凡在 ASCP经营范围内活动的申请人，均可享受 ASCP的服务。ASCP不以组织规模、协会或机构的会员资格或已颁发证书的数量来限制认证的实施。最高管理层对认证服务过程中的公正性声明如下：


- ASCP top management has a deep understanding of the importance of impartiality in the implementation of certification activities, providing impartial and competent certification services to all parties concerned, and providing trust to all parties concerned ASCP;/最高管理层深刻理解公正性在实施认证活动中的重要性，为所有认证相关方提供公正、有能力的认证服务，向所有认证相关方提供信任；
- ASCP always insists on independence and impartiality, making decisions on granting or not granting certification only based on inspection evidence;/ ASCP始终坚持独立与公正，仅根据检查证据做出授予或不授予认证的决定；
- ASCP fully recognizes, analyzes and documents conflicts of interest arising from certification activities, and effectively manages and controls activities and relationships that affect impartiality. To ensure that impartiality is not affected in any way by other interests or other parties (units or individuals); /ASCP对由认证活动引起的利益冲突进行充分认识和分析并形成文件，对影响公正的活动和关系进行有效管理和控制。确保公正性不受其他利益或其他各方（单位或个人）的任何影响；

- ASCP does not provide consulting services in any way, does not cooperate with any consulting institutions, independently signs certification contracts, and does not imply that if the applicant chooses a consulting or training institution, it can make certification simpler, easier, faster or cheaper, nor does it allow any link or statement of consulting institutions to declare or imply;/ASCP不提供任何方式的咨询服务，不与任何认证咨询机构有合作关系，独立签署认证合同，更不暗示申请方若选择某家咨询或培训机构，可使认证更为简单、容易、迅速或廉价，也不允许任何咨询机构的链接或声明宣称或暗示；
- ASCP certification personnel (including management and inspection personnel) who have provided certification consultation to the organization shall not be used for inspection or other certification activities against the organization for two years after the completion of the consultation;/ASCP的认证人员（包括管理人员、检查人员）如曾经对组织提供过认证咨询，在咨询结束后两年内，不被用于针对该组织的审核/检查或其他认证活动；
- ASCP does not provide any other product and service that may impair the confidentiality, objectivity or impartiality of its certification process and decisions, and actively manages the identification, elimination and reduction of these risks./ ASCP不提供任何其他可能损害其认证过程和决策的保密性、客观性或公正性的产品和服务，并积极管理这些风险的识别、消除和减少。
- All ASCP employees, whether internal or external, or members of committees and board are committed to acting impartially, disclosing any potential or existing conflicts of interest, or any situation (commercial, financial, personal or any other relationship) that may pose a risk to impartiality./ 所有 ASCP员工，无论是内部还是外部，或委员会的成员、董事会成员都致力于公正行事，披露任何潜在的或现有的利益冲突，或任何可能对公正构成风险的情况(商业、财务、个人或任何其他关系)。
- All ASCP employees in any occasion will not accept gifts from certification organizations, including gifts, gifts, securities, jewelry, etc;/ ASCP所有工作人员在任何场合均不收受认证组织的馈赠，包括礼金、礼品、有价证券、珠宝首饰等；
- ASCP auditors shall not participate in the banquets and entertainment arranged by the organization when performing their inspection tasks./ASCP检查人员在执行检查任务时，不参加受检查方安排的宴请和娱乐活动。
- ASCP and any affiliate under the same legal entity shall not produce, trade, manufacture, or otherwise handle cotton from Better Cotton certified producers or suppliers. Additionally, ASCP and its affiliates shall not offer or provide consultancy services related to Better Cotton certification to organizations, including but not limited to the evaluation or internal auditing of management systems./ASCP及其同一法律实体下的任何关联公司不得生产、交易、制造或以其他方式处理来自良好棉花认证生产者或供应商的棉花。此外，ASCP及其关联公司不得向组织提供与良好棉花认证相关的咨询服务，包括但不限于管理系统的评估或内部审计。

4.1.3 Management of Confidential Information/保密信息的管理

Through the legally binding contractual agreement, ASCP is responsible for the confidential management of all information obtained or generated during the certification process. All information will be treated as confidential with the following exceptions:/ 通过具有法律约束力的合同协议，ASCP负责对认证过程中获得或产生的所有信息进行保密管理。所有信息将被视为机密，但以下情况除外：

- Information disclosed by the customer itself or as agreed between ASCP and the customer, if in response to a complaint./ 组织自身或 ASCP与组织达成协议，因投诉而披露的信息。
- When ASCP is required to make publicly available information that maybe considered as confidential information, ASCP will notify the organization in advance./ 当 ASCP被要求公开可能被视为机密信息的信息时，ASCP将提前通知组织。
- When ASCP is required to disclose some information based on legal requirements. ASCP will notify Better Cotton and the customer/individual concerned of the information provided, unless restricted by law./ 当 ASCP根据法律要求需要披露某些信息时。除非法律另有规定，否则 ASCP会将所提供的资料通知有关组织或个人以及良好棉花。


Information about customers obtained from sources other than customers (such as complainants, regulatory authorities) shall be treated as confidential information./ 从组织以外的来源(如投诉者、监管机构)获得的组织信息应被视为机密信息。

Files presented to any relevant ASCP committees are prepared in such a way that no details are included that may identify the organization or the products in question and all sensitive information is removed./ 提交给 ASCP任何相关委员会的文件均不包括可能识别组织或相关产品的细节，并删除所有敏感信息。

The confidentiality obligations in regard to the customer confidential information that set forth in this Section shall survive the termination or expiration of the Agreement for ASCP for a period of five years./关于本节中规定的组织保密信息的保密义务，在 ASCP协议终止或到期后，将继续有效五年。

- a) ASCP is committed to making information publicly available regarding its management structure, certification procedures, appeals and complaints procedures. /ASCP致力于将其管理结构、认证程序、申诉和投诉程序等信息公开。

- g) No information related to a specific product or supplier shall be provided to any organization without the written consent from the relevant supplier./未经相关供应商的书面同意, 不得向任何组织提供与特定产品或供应商相关的信息。

4.1.5 Use of certificates and marks of conformity/证书和合格标志的使用

Compliance certificates and mark usage requirements are defined in certification contract and Better Cotton's specific labeling guidelines. By accepting the certification contract form ASCP, the organization undertakes to meet all relevant requirements. Organization shall only use marks upon signing a license agreement with Better Cotton./证书和标志使用要求在认证合同和良好棉花的具体标签指南中定义。通过接受 ASCP的认证合同, 组织承诺满足所有相关要求。组织仅能与良好棉花签订许可协议后使用这些标志。

Any inappropriate or deceptive reference or use will be investigated by ASCP. If the mark is used improperly, it will be punished including withdrawal or suspension of certification documents or legal procedures./ 任何不适当或欺骗性的引用或使用将由 ASCP调查。如果使用不当, 将受到吊销或中止认证文件或法律程序等处罚。

4.1.6 Derogation to certification requirements/认证要求的放宽或免除

ASCP will not grant any derogation against any certification requirements. In case when a specific situation may warrant an exception or derogation, ASCP will refer the case back to Better Cotton./ ASCP不会对任何认证要求给予任何减损。如有特殊情况需要放宽或免除，ASCP会将个案转介给良好棉花。

4.1.7 Variations/变化

When individual organizations seek to deviate from any of the requirements outlined in the Better Cotton normative documents they must first consult with and obtain written approval from ASCP before submitting a variation request to the Better Cotton team. This approval should be evidenced along with the variation request, which needs to be submitted via email to compliance@bettercotton.org. 5. Certification process/认证流程


5.1 General/总则

The audit cycle for organization in the Better Cotton supply chain is defined on a 3-year cycle as in the example below./良好棉花供应链中组织的审核周期定义为 3 年周期，如下例所示。

It should be noted that the type of audit can vary if a negative decision is reached or if heightened risk factors have been identified in the organization/应该注意的是，如果做出了否定的决定，或者在组织发现了更高的风险因素，审核的类型可能会有所不同。

The organization shall ensure that they arrange a re-audit to be conducted at least 60 days prior to the certificate expiry date. ASCP shall follow all the same processes and steps at a re-certification audit as is done for an initial certification audit./组织应确保在证书有效日前至少 60 天安排重新

5.2 Certification application/认证申请

ASCP will require receiving the application form filled in with all the relevant information and signed by the legal representative or authorized representative of the applicant organization. The following document will need to be submitted:/ ASCP将要求收到填妥所有相关资料并由申请人机构法人代表或授权代表人签署的申请表。申请人须提交以下文件：

- The relevant ASCP Certification application form/有关的 ASCP认证申请表格

When receiving an application from a potential organization, ASCP will check that the information provided is complete and if it is the case will send to all applicants the following information:/ 当收到潜在组织的申请时，ASCP将检查所提供的信息是否完整，如果是这样，ASCP将向所有申请人发送以下信息：

- The commercial proposal and contractual agreement to signed by the legal representative of the applicant organization. By signing the contractual agreement, the applicant organization

- The audit plan will be sent at least two weeks prior to the first day of the onsite audit. - A conflict of interest that could have a potential or perceived impact on ASCP certification decision,/ 可能对 ASCP认证决定产生潜在或感知影响的利益冲突，
- A lack of ASCP qualified personnel,/ASCP缺乏有资质的人员

5.3 Initial Document review/初始文件评审

ASCP will perform a document review which will be carried out through a review of the documented system and records specific to the activities of the applicant organization with regards to Better Cotton Chain of Custody standard. / ASCP将通过申请组织在良好棉花监管链标准方面的活动的文件体系和记录的审查进行文件审核。

Documented procedures and records requested will be related to the relevant certification standard./ 要求形成文件的程序和记录应与相关的认证标准相关。

Following the initial document review, ASCP will prepare and will send the applicant organization an audit plan as indicated in section 5.2./ 在初步文件评审之后，ASCP将按照 5.2 节中的规定准

ASCP lead auditor in charge of coordinating and performing audit activities will contact the applicant organization to request access to all relevant information to perform the initial document review and prepare for the onsite audit. /负责协调和执行审核工作的 ASCP审核组长将与申请组织联系，要求获得所有相关信息，以便为现场审核做准备。


The initial document review is part of the initial certification audit and any results from this initial review process is included in ASCP final audit report that is produced at the end of the certification audit process, covering both the document review and onsite audit. /初始文件审核是初始认证审核的一部分，初始审核的任何结果都包含在ASCP最终审核报告中，并在认证审核结束时生成，包括文件审核和现场审核。

5.4 Onsite audit/现场审核

ASCP conducts onsite audits to ensure conformity of the applicant organization procedures, processes and products with the requirements of the relevant certification standard. /ASCP进行现场审核，以确保申请人组织的程序、过程和产品符合相关认证标准的要求。

ASCP onsite audits include the following steps:/ ASCP现场审核包括以下步骤:

- An opening meeting to be performed by ASCP lead auditor in compliance with ASCP auditing best practices, /由ASCP审核组长按照 ASCP审核最佳实践进行首次会议，
- A review of previous nonconformities whenever relevant, /对以前的不符合项进行评审，

- An onsite audit of all the relevant production facilities as well as storage areas, /对所有有关的生产设施和储存区域进行现场审核；
- During the onsite audit, ASCP audit team may require to take product sampling for testing whenever required by the certification standard. - Interviews of a representative sample of relevant personnel, both on the production site or in the office. For onsite audits, the applicant organization shall provide ASCPaudit team with safe access to its facilities and in particular shall ensure that ASCP audit team is fully informed about any potential H&S hazard within the production area and shall be provided with the relevant required PPE./ 对于现场审核，申请组织应为 ASCP审核组提供进入其设施的安全通道，尤其应确保 ASCP审核组充分了解生产区域内的任何潜在的健康安全危害，并提供相关所需的个人防护装备。

5.5 Management of audit findings/审核发现的管理

ASCPaudit teams may issue non-conformities during ASCP certification audits. Each non-conformity identify requires appropriate corrective action(s) to resolve the non-conformity identified within a specific timeframe./ASCP审核组在认证审核时期间会提出不符合项，每一项不符合项都需要在特定的时间范围内采取适当的纠正措施来解决所辨别出的不符合项。

ASCP classifies nonconformities as follow, to reflect the level of nonconformity identified during the audit: /ASCP将不符合分为以下几类，以反映审核过程中发现的不符合程度:

- Minor non-conformity/ 轻微不符合项: an isolated event that is limited in temporal and spatial scale, and where an effective internal management system was in place that should have prevented or detected the issue. A NC can also be graded as Minor if it does not result in a fundamental failure to achieve the objective of the relevant requirement./一个局限于特定时间和地点范围内的孤立事件，并且在事件发生时已经存在一个有效的内部管理系统，该系统本应能够防止或发现此问题。如果某项不符合（NC）并未导致无法达成相关要求的根本目标，那么这项不符合也可以被分级为轻微级别。
- Major non-conformity/重大不符合项: if it results in, or is likely to result in, a fundamental failure to achieve the objective of the relevant requirement (either alone or in combination with other NCs). The auditor shall issue any non-conformities relating to deliberate fraud (including but not limited to altering any records related to claimed material by the organization's personnel) as a Critical NC./审核员应当将涉及故意欺诈的所有不符合项（包括但不限于由组织方人员篡改与声明材料有关的任何记录）列为关键不符合项提出。

The auditor shall report to Better Cotton within 24 hours if they detect any kind of unethical

conduct from the staff representing the organization, including the offering of bribes in any kind or cash. This will lead to negative audit decision./若审核员发现组织方工作人员存在任何不道德行为，包括但不限于任何形式的贿赂或现金交易，应在 24 小时内向良好棉花组织报告。此情况将导致负面的认证决定。

If, during audits or monitoring activities, NCs are identified against CoC Standard requirements, the organization shall submit their corrective action plan (including a correction) within the specified timeframes./如果在审核或监控活动中发现针对监管链标准要求的不符合项，组织应在规定的时间范围内提交其纠正措施计划（包括纠正行动）。

- Minor non-conformities shall be corrected within 60 calendar days of the audit and the organization shall provide evidence to ASCP auditor demonstrating how the issue has been addressed./对于轻微不符合项，应在审核完成后的 60 个日历日内进行纠正，同时组织应向 ASCP 审核员提供证据，证明该问题已被妥善处理。

The CAP shall include a description of the root cause of the non-conformity and the corrective actions intended to correct the non-conformity./纠正行动计划（CAP）应当包含对不符合项根本原因的描述，以及为纠正此不符合项所计划采取的具体纠正措施。

If the organization fails to submit their CAP within the timeline, the organization's BCP account shall be temporarily suspended until it provides a valid reason for delay, or submits the CAP./如果该组织未能在规定时间内提交其 CAP，则组织的 BCP 账户将暂时被暂停使用，直至其给出延迟的原因说明或提交 CAP。

If non-conformities are not corrected within the designated timeframe a certificate shall not be awarded, and an additional audit may be required. 5.6 Audit Result and Certification decision making process/审核结果及认证决定的过程

After each audit, the auditor shall complete a report using the Better Cotton CoC Audit Report./每次审核后，审核员应使用良好棉花监管链审核报告完成一份报告。

ASCP shall submit a copy of the finalised audit report and certificate to the organization along with compliance@bettercotton.org within 14 calendar days of receipt of the correction action plan (including correction). Where no non-conformities were identified ASCP shall submit a copy of the finalised audit report and certificate to the organization along with compliance@bettercotton.org within 14 calendar days of the final day of the audit./ASCP应在收到纠正行动计划（包括纠正措施）后的 14 个日历日内，向组织及 compliance@bettercotton.org 提交最终审核报告和证书的副本。如果审核中未发现不符合项，ASCP应在审核最后一天起的 14 个日历日内，向组织及 compliance@bettercotton.org 提交最终审核报告和证书的副本。

ASCP certification decision is taken by a qualified ASCP personnel who is qualified and has not taken part in any of the certification activities. To make an appropriate certification decision, ASCP certifier will review the following documentation: /ASCP认证决定由合格的 ASCP人员做出，但该人员没有参加任何认证活动。为了做出适当的认证决定，ASCP认证机构将审查以下文件：

- ASCP audit report./ASCP审核报告
- The nonconformities that have been identified and reported during ASCP audit. /ASCP审核期间发现并报告的不符合项。
- The corrective action plan and corrective actions implemented to close all relevant nonconformities./纠正措施计划和为关闭所有相关不符合项而实施的纠正措施。

The applicant organization will only be informed of a positive certification decision, when: /只有在下列情况下，申请机构才会被告知认证结果是积极的：

- All relevant certification fees have been paid by the applicant organization, and 所有相关的认证费用已由申请组织支付;及
- All relevant certification requirements have been fulfilled, and/所有相关认证要求均已满足，并且
- The number of NCs is less than the allowable number outlined in document Better Cotton CoC Monitoring and Certification Requirements./NCs 的数量少于文件《良好棉花监管链监测和认证要求》中概述的允许数量。
- A positive certification decision has been taken by the relevant ASCP qualified personnel. /相关的 ASCP 资质人员作出了积极的认证决定。

After the socpe certificate is issued with the list of certified products, the organization is required to ensure that certified products remain in full compliance with all the requirements of the relevant standard, shall allow for surveillance audits to be performed as required, and shall ensure timely payment of all relevant certification and surveillance audit fees./带有认证产品列表的证书签发后，认证组织应确保认证产品仍然完全符合所有相关标准的要求，允许监督审核应按要求执行，并确保及时支付所有相关认证和监督审核费用。

Certificates shall be valid for a maximum of three years from the date of issue. The expiry date of the certificate shall be based on the issue date./证书自签发之日起，有效期最长不超过三年。证书的到期日期基于签发日期。

A negative decision shall be issued to the organization that exhibits fundamental failure to achieve the objective of the CoC requirements, which includes the following cases:/如果根本未能实现监管链标准要求的目标，应向组织发出否定决定，包括以下情况：

- Any NC(s) has not been corrected;/存在任何不符合项没有纠正；
- The number of NCs exceeds the threshold identified in Table 1 outlined in document Better Cotton CoC Monitoring and Certification Requirements;/不符合项的数量超过了文件《良好棉花监管链监督和认证要求》中表 1 中确定的阈值；
- Better Cotton or a designated ASCP auditor has evidence of a NC that was induced purposefully, grossly negligent, systematic, and/or which imposes a severe reputational risk to Better Cotton stakeholders;/良好棉花或指定的 ASCP审核员有证据证明有目的、严重疏忽、系统性和/或对良好棉花利益相关者造成严重声誉风险的不合格行为；
- No response to submit a CAP within specified time period of receiving the final audit report and CAP template./在收到最终审核报告和 CAP 模板后的规定时间内未提交 CAP。

Where the organization is certified ASCP shall suspend the certificate and inform the organization and Better Cotton of this decision within 2 days of making the decision. In addition, Better Cotton retains the right to suspend use of the BCP at any time if Better Cotton or a designated ASCP auditor has detected any kind of unethical conduct which may include bribery or fraud. 5.7 Annual Self-Assessment/年度自我评估

As per Section 2.8 of the CoC Standard all organizations are required to complete an annual self-assessment. The self-assessment shall be completed using a template provided by Better Cotton and shall be submitted to ASCP or Better Cotton. ASCP and/or Better Cotton may evaluate the self-assessment and request further information on the outputs of the internal review./根据《良好棉花监管链标准》第2.8节的规定，所有组织都需要每年完成一次自我评估。自我评估应使用良好棉花提供的模板完成，并提交给 ASCP 或良好棉花。ASCP 和/或良好棉花可能会对自我评估进行评估，并要求提供关于内部审查结果的进一步信息。

Failure to cooperate with requests from the ASCP and/or Better Cotton shall result in the ASCP suspending the organization's certificate and Better Cotton shall block the respective BCP account until the information is provided. If the information provided is of poor quality or raises concerns, ASCP and/or Better Cotton may request further information and conduct additional monitoring./未能配合 ASCP 和/或良好棉花的要求将导致 ASCP 暂停组织的证书，且良好棉花将封锁相应的 BCP 账户，直到提供所需信息为止。如果提供的信息质量差或引起关注，ASCP 和/或良好棉花可能会要求提供进一步的信息并进行额外的监控。

5.8 Surveillance/监督检查

Where a organization reaches the non-conformity threshold of 'Positive Result and Surveillance Audit' listed in Table 1 outlined in document Better Cotton CoC Monitoring and Certification Requirements they shall undergo a surveillance audit within 12 months of the certification (or recertification) audit./如果组织达到文件《良好棉花监管链监控和认证要求》中表 1 所列的“积极结果和监督审核”的不合格阈值，组织应在认证（或再认证）审核后 12 个月内接受监督审核。

The surveillance audit shall be conducted by the same CB that conducted their certification (or recertification) audit./监督审核应由进行其认证（或再认证）审核的认证机构进行。

ASCP shall perform annual surveillance to ensure continuous conformity with the relevant certification requirements. Surveillance can be announced or unannounced onsite audit, product

sampling for compliance tests and Checks on the implementation of remedial action. /ASCP应进行年度监督审核，以确保持续符合相关认证要求。监督审核可以是通知或不通知的现场审核、产品抽样符合性测试和检查纠正措施的实施。

The surveillance activities are planned and carried out in the manner stated in the relevant Standard Documents./监督活动是按照有关标准文件所述的方式计划和执行的。

Any non-conformities raised at a surveillance audit shall be handled as per Section 5.5 of this document and will have the same consequences as those raised in a certification (or re-certification audit). Prior to performing an announced periodic surveillance audit, ASCP shall send to the certified organization an audit plan two weeks prior to the opening meeting of the audit. For unannounced audits, ASCP is not required to send an audit agenda in advance of the audit./ 在执行监督审核前，ASCP应于首次会议召开两周前，向被认证组织发送审核计划。对于不通知的审核，ASCP不需要在审核前发送审核计划。

Announced surveillance audits will be performed with the following activities: /通知的的监督审核将进行下列活动:

- Documents and records review/文件和记录评审
- Onsite audit of production area(s) including storage area(s)/ 生产区域(包括仓库)的现场审

Unannounced surveillance audits may be required in the following situations: /在下列情况下，可能需要进行不通知的监督审核：

- Evidence of misleading claims by the certified organization, including misuse of the certificate./ 认证组织有误导性声明的证据，包括误用证书。
- Justified and documented complaint(s)/合理的和文件化的投诉。
- In case of fraud, such as after a suspension decision there is evidence that the organization is still trading certified products./ 如有欺诈行为，例如在被暂停交易后，有证据表明该组织仍在交易认证产品。
- In case of court case that may indicate that the organization has not fully complied with all relevant certification requirements. /如在诉讼案件中发现该机构没有完全遵守所有有关的认证规定。
- At the request of Better Cotton. /应标良好棉花的要求


ASCP surveillance audits are normally performed through document review and an onsite audit .However, in case of special circumstances and if allowed by the Better Cotton, ASCP may perform remote surveillance audits./ ASCP监督审核通常通过文件审查和现场审核进行。但是，在特殊情况下，如果良好棉花允许，ASCP可以进行远程监督审核。

5.9 Renewal audit/复审

Renewal audits should be completed no later than 60 days prior to the expiry of a scope certificate. Renewal audits are announced audits that follow the same process flow as an initial certification audit./ 复审审核应不迟于范围证书到期前 60 天完成。更新审核是按照与初始认证审核相同的流程进行的通知审核。

Renewal audits shall be performed through document review and an onsite audit, unless any particular exception granted by the scheme owner./复审应通过文件审查和现场审核进行，除非标准制定方批准任何特殊的例外情况。

ASCP will need to make a new certification decision after each renewal audit. If major or critical nonconformities are detected during a renewal audit, ASCP may take a negative certification decision and the organization's certificate may not be renewed until full conformity with the relevant requirements have been demonstrated./ ASCP需要在每次复审后做出新的认证决定。如

5.10 Scope extension/扩大范围

A certified organization may require for its certificate scope to be extended and/or add new CoC models at any stage during the three years of the certification cycle. A formal written request for scope extension shall be sent to ASCP before any related claim can be made./ 认证组织可在三年的认证周期内的任何阶段要求扩大其认证范围和/或增加新的监管链模式。组织在提出任何相关声明之前，应向 ASCP发出正式的扩大范围的书面请求。

Scope extension requires a document review and/or on-site audit to take place and a formal decision making process shall be followed as per ASCP procedures./ 扩大范围需要进行文件审查和/或现场审核，并按照 ASCP程序进行正式的认证决定流程。

Scope extension can be granted or rejected based on the outcome of the ASCP audit./可根据 ASCP 审核结果批准或拒绝扩大范围。

ASCP shall issue an updated certificate to organization upon either approval of the extension or successful completion of the on-site audit. The expiry date of the existing certificate shall remain as it was before the extension was added./ASCP应在完成对延期申请的批准或在现场审核成功结束后，向相关组织发放新版证书。原有证书的到期日期将维持原状，即不因延期的批准而发生改变，其有效期截止日与最初颁发时设定的日期保持一致。

5.11 Certification suspension/认证暂停

ASCP may suspend a certificate in the following (but not limited to) circumstances:/ 有下列情形之一，ASCP可以暂停证书：

- CAP is not submitted by the required deadline, or is incomplete and/ or insufficient quality;/CAP 未在规定的截止日期前提交，或不完整和/或质量不足；
- Failure to close out non-conformities from monitoring activities;/未能关闭监督活动中的不符合项。
- Scheduled audits are not carried out or access is restricted (e.g. ASCP is not permitted access to certain documents or sites required for the full audit);/未进行计划审核或准入受到限制（例如，不允许 ASCP进入全面审核所需的某些文件或场所）；
- Failure to cooperate with ASCP auditors in monitoring activities;/在监督活动中不配合 ASCP 审核员；
- This includes refusing to allow entry to a organization for the purpose of an audit;/包括拒绝以审核为目的的访问；
- Demonstrable breakdown in the Chain of Custody;/监管链出现明显故障；
- Evidence a organization has sold products as Physical Better Cotton when they are shown to

- Breaches in other Better Cotton processes including, but not limited to: membership requirements, Better Cotton Claims Framework requirements, and BCP terms and conditions as well as misuse of the BCP;/其他良好棉花流程中的违规行为，包括但不限于：会员要求的违反、良好棉花声明框架要求的违反、以及 BCP 条款和条件的违反和 BCP 的滥用；
- Significant changes to the organization's processes that may have an impact on the product's compliance with relevant standard requirements and that have not been communicated to ASCP;/ 组织的工序有重大变化，可能会影响产品符合相关标准要求的，且未告知 ASCP。
- Fraud, wrong claims or misuse of the certificate;/虚假错误的声明或者滥用证书；
- Failure to pay relevant certification fees./未支付相关认证费用
- Issues that may bring Better Cotton into disrepute;/那些可能会使良好棉花蒙羞的问题；
- Unethical behaviour (bribery, corruption, etc.)/不道德行为(贿赂、腐败等)。

ASCP will notify in writing the organization of the decision to suspend a certificate, specifying thereasons for the suspension and the condition(s) for the suspension to be lifted. ASCP shall alsoinform Better Cotton within 48 hours of the suspension./ ASCP将会以书面通知组织暂停证书的决定，说明暂停证书的原因和取消暂停证书的条件。ASCP也会在 48 小时内将暂停通知良好棉花。

The period of suspension shall be determined according to Table 2 on document Better Cotton CoC Monitoring and Certification Requirements along with actions required to lift suspension. Failure to take acceptable actions to correct the cause of the suspension may result in the organization being removed from the Better Cotton programme and they shall be required to go through a new certification audit with ASCP./暂停期限将根据《良好棉监控和认证要求》文件中的表 2 来确定，同时包含解除暂停所需采取的措施。如果未能采取可接受的纠正措施来解决导致暂停的问题，可能会导致组织被移出良好棉花计划，并且需要与 ASCP进行新的认证审核。

5.12 Certification Withdrawal and Cancellation/认证撤销和取消

ASCP may withdraw a certificate in the following circumstances:/ 有下列情形之一者，ASCP得终止证书：

- Issues that may bring Better Cotton into disrepute;/导致良好棉花蒙羞的问题；
- Failure to lift suspension within the specified timeframe;/未能在指定的时间内解除暂停；
- Unethical behaviour, serious and repeated or systematic fraud, wrong claim or misuse of the certificate; /多次或有系统地进行严重欺诈、错误申领或误用证书；
- Failure to pay ASCP for audit services provided associated with the Better Cotton Chain of Custody programme;/未能向ASCP支付与良好棉花监管链计划有关的审核服务费用；

ASCP may cancel a certificate in the following circumstances:/ 有下列情形之一者，ASCP得终止证书：

- In case of bankruptcy or if the organization closes its business./ 如果组织破产或关闭业务
- If the legal representative of the certified organization makes a formal request for the certificate to be terminated at any stage./认证机构的法定代表人在任何阶段正式要求终止该证书。


ASCP will notify in writing the organization of the decision to terminate a certificate, specifying thereasons for the suspension./ ASCP将书面通知组织机构终止证书的决定，并说明中止证书的原因。

CB shall inform Better Cotton within 48 hours of the withdrawal who shall suspend the organization's BCP account./CB 应在 48 小时内将撤销通知良好棉花，后者将暂停该组织的 BCP 账户。

5.13 Changes to certification requirements/认证要求的变更

ASCP shall inform all its organizations for Better Cotton Chain of Custody Standard of any change to the standards requirements within 10 working days, along with the timeline for implementing any changes./ASCP将在 10 个工作日内告知其组织关于良好棉花监管链标准的标准变更及实施变更的截止日期。

As per Section 2.2 of the Better Cotton Chain of Custody Standard (live version), organization shall communicate any changes in the management representative, or any other significant changes to ASCP by email within 15 calendar days of the change occurring./根据良好棉花监管链标准（实时版本）第 2.2 条，组织应在变更发生后 15 个日历日内通过电子邮件将管理层代表的任何变更或任何其他重大变更通知 ASCP。

5.14 Transfer of Certificates/证书转移

The organization shall inform their existing Certification Body (CB) at least 3 months prior to their certificate expiry should they choose to change CB for their next audit./组织如果选择在证书到期前更换认证机构（CB）进行下一次审核，应至少提前 3 个月通知现有的认证机构。

If a organization contacts ASCP with a request to transfer their certificate, ASCP shall request and review the latest audit report(s) and any other relevant supporting documents (e.g. Corrective Action Plan, etc)./如果组织联系 ASCP 请求转移其证书，ASCP 将要求并审查最近的审核报告和任何其他相关的支持文件（例如，纠正行动计划等）。

If an audit is not yet due ASCP may issue a certificate for the length of time remaining on the previous certificate, based on the review evidence from the previous audit./如果审核尚未到期，ASCP 可以根据之前审核的审查证据为组织颁发有效期至原证书剩余时间相同的证书。

The organization shall be responsible for ensuring that the previous CB is informed, and the contract is cancelled as soon as the contract with ASCP is signed./在与 ASCP 签订合同后，组织有责任确保先前的 CB 已被告知，并且合同已终止。

6. Complaints and Appeals/投诉和申诉

6.1 General/总则


ASCP operates and delivers certification services to the highest professional standards. However, in specific circumstances, you may wish to raise a formal complaint against some of the services delivered by ASCP or appeal a specific certification decision./ ASCP 以最高的专业标准运作和提供认证服务。然而，在特殊情况下，您可能希望对 ASCP 提供的某些服务提出正式投诉，或对特定的认证决定提出申诉。

In order to offer fair and impartial certification decision services, ASCP is implementing formal complaint and appeal procedures that are described in the sections below./为了提供公平和公正的认证决定服务，ASCP 正在实施正式的投诉和申诉程序，这些程序在下面章节中描述。

6.2 Management of Complaint received/管理收到的投诉

ASCP Sustainable textile certified organizations shall develop and implement a documented procedure for the management of complaints received from third parties. The procedure must include the following requirements: /ASCP 可持续纺织品认证机构应制定并实施一套文件化程序，用于管理来自第三方的投诉。该程序必须包括以下要求：

- Record any complaint raised from any interested stakeholders,/记录任何有关利益相关者提出的投诉；

- Document and record the results of any investigation performed with respect to the complaint received, /就接获的投诉所进行的任何调查结果，记录在案，
- Document and record any action taken to address and resolve the complaint received./记录为处理和解决收到的投诉而采取的任何行动。

6.2 Complaint against ASCP/投诉

An organization or any interested party may send a complaint to ASCP. A complaint raised to ASCP shall comply with the following minimum requirements to be considered by ASCP as a formal complaint: /组织或任何相关方可向ASCP投诉。向ASCP提出的投诉须符合以下最低要求，ASCP方可视为正式投诉：

- Be in writing. ASCP will not consider informal complaints that are not provided in written format, /用书面形式。ASCP不会考虑没有以书面形式提供的非正式投诉；
- Shall not be anonymous,/不能匿名；
- Be fully justified with appropriate description of the issue raised and how this is related to the ASCP audit, certification process or any other relevant ASCP activity./对所提出的问题进行充分合理的描述，并说明其与 ASCP审核、认证过程或其他相关 ASCP活动的关系。


ASCP will record all formal and justified complaints received, will review the complaint within 15 working days after reception, and is committed to responding to the complainant(s) within 30 calendar days. If additional time is required to review, address and/or respond to the complaint, ASCP will formally inform the complainant and will propose a new timeline to respond. /ASCP将记录所有收到的正式且合理的投诉，并将在收到投诉后 15 个工作日内对投诉进行审核，并承诺在 30 个自然日内对投诉人做出回应。如果需要额外的时间来审查、处理和/或回应投诉，ASCP将正式通知投诉人，并提出新的回复时间。

ASCP will ensure that complaints are not reviewed and addressed by any ASCP personnel whom may have a conflict of interest./ ASCP将确保投诉不被任何可能有利益冲突的 ASCP人员审查和处理。

ASCP will record each complaint that has been accepted together with the action taken to resolve the issue and the response that was sent to the complainant./ ASCP将记录已受理的每一个投诉，以及为解决该问题所采取的行动和发送给投诉人的答复。

Any changes in certification status resulting from an appeal shall be communicated to Better Cotton and the appellant in writing within 5 working days of the decision being made./任何因上诉而产生的认证状态变更，应在做出决定后的 5 个工作日内以书面形式通知良好棉花和申诉人。

If the complainant is not satisfied with ASCP response, ASCP will provide the contact details of Better Cotton so that appropriate follow-up can take place at the level of Better Cotton. /如投诉人对 ASCP 的回应不满意，ASCP 会提供良好棉花的联络资料，以便在良好棉花层面进行适当的跟进。

6.3 Appeal/申诉

ASCP will only receive formal appeals from ASCP applicant or certified organizations. Appeals have to be specifically related to: /ASCP只接受来自ASCP申请人或认证组织的正式申诉。申诉必须具体涉及:

- A ASCP certification decision,/ ASCP认证决定;
- A decision by ASCP to suspend or terminate a certificate,/ ASCP暂停或终止证书的决定
- ; A nonconformity raised by ASCP audit team during an audit process./ ASCP审核组在审核过程中提出的不符合项。

The auditee or the certified organization will appeal to ASCP within 30 days after receiving the decision or notice of action. Appeal must: /被审核方或被认证组织将在收到决定或行动通知后30 天内向ASCP提出申诉。申诉必须:

- Be in writing,/通过书面;
- Be signed or sealed by the complainant/由投诉人签名或盖章;
- Be fully justified, presenting all relevant evidence related to the case,/ 有充分理由, 提出与本案有关的所有证据;
- Be with clear reference to relevant normative reference./明确参考相关的规范。

All appeals will be dealt with as per ASCP appeal procedure, as follow: 所有申诉将按照 ASCP申诉程序处理, 如下:

- Appeal will be reviewed by a qualified ASCP personnel who has not been involved in any certification activity related to the organization,/ 申诉将由一名合格的 ASCP人员进行审查, 该人员未参与任何与组织有关的认证活动,
- ASCP can reject an appeal if the evidence provided is not sufficient to justify for ASCP decision to be reviewed./如果所提供的证据不足以证明对 ASCP的决定进行复审, ASCP可以驳回申诉。
- If the appeal is accepted, the Textile Certification Department fills in the “Appeal/Complaint and Dispute Acceptance Record” and reports to ASCP's top management and management representatives within 2 working days. The investigation team shall be composed of personnel who have not audited and certified the party involved in the appeal, and the management representative appoints the head of the investigation team to conduct an investigation./如申诉获接纳, 纺织认证部在收到申诉材料后, 在 2 个工作日内填写《申诉/投诉及争议受理记录》, 并向公司最高管理者和管理者代表报告。调查组由未对申诉当事人进行审核和证明的人员组成, 由管理者代表任命调查组组长进行调查。
- The investigation team organizes investigation, confirmation, analysis and evidence collection of the appeal: /调查组组织申诉的调查、确认、分析和证据收集:
 - o Both the complainant and the respondent should be required to provide sufficient factual evidence and written materials. /要求申诉方与被申诉方均应提供充分的事实证据和书面材料
 - o The working group shall arrange for the representatives of the party to appeal and the party to response to present their reasons fully./工作组应安排申诉方与被申诉方代

- Investigate, confirm, analyze and collect evidence of the reasons and facts of the appeal to determine the validity of the application./对申诉理由和事实进行调查、确认、分析和取证，以确定申请的有效性。
- Propose the relevant measures to respond to the appeal, that is, to process opinions or conclusions./ 提出回应申诉的相关措施，即处理意见或结论。

- The leader of the investigation team convened a meeting to review the results of the treatment and, if necessary, refer to the results of previous similar complaints./调查组组长召开会议，审定处理结果，必要时可以参考以前类似申诉的结果。
- The reasons for the appeal are established and are the responsibility of the company. The representative of the company manager is responsible for organizing the relevant departments to analyze the reasons for non-conformity according to the relevant provisions of the Procedures for Corrective/Preventive Measures, taking corrective measures, forming documents and verifying their validity. When the auditee or the certified customer is required to review, the Textile Certification Department shall conduct the review in accordance with the requirements in the certification procedure. /申诉理由成立，属公司责任，公司管理者代表负责按照《纠正/预防措施程序》中有关规定，组织相关部门分析不符合产生的原因，采取纠正措施，形成文件并验证其有效性；如果认为对受审核方或获证组织应予复审时，由纺织认证部按照认证程序中的要求实施复审。
- The problem in the appeal is not the responsibility of the company, but it is related to the company's certification audit work, and should be taken in the same way, and appropriate improvement measures should be taken. /申诉中的问题不属于公司的责任，但与公司认证审核工作有关，应举一反三，采取适当的改进措施。
- The reasons for the appeal are established, and the costs of the appeal investigation and the cost of the review are borne by the company. The reason for the appeal is not established and the claimant shall bear the expenses. /申诉理由成立，申诉调查处理费用及复审费用由公司承担。申诉理由不成立，由申诉方负担费用。
- The confirmation of the appeal and the progress of the investigation and the final processing result shall be sent to the appealing party in writing by the Textile Certification Department. The final processing result will be accepted from the formal acceptance, no later than 30 calender days./申诉的确认和调查处理进展情况和最终处理结果，由纺织认证部以书面形式送交申诉方。最终处理结果自正式受理申诉，最迟不超过 30 个自然日。

Please note that an appeal, even if accepted by ASCP, is not suspensive of the decision subject to the appeal./请注意，申诉即使被 ASCP 接受，也不意味着申诉后的决定被中止。

In the event of an unsuccessful appeal the organization may appeal to Better Cotton. The appeal to Better Cotton shall only be made if the organization has reason to believe that ASCP has not followed the processes outlined in this document and/or a conflict of interest has been

This appeal shall be made within 10 calendar days of the appeal decision received by the ASCP. Failure to submit in this timeline shall result in Better Cotton not reviewing the appeal. Better Cotton shall acknowledge the appeal within 10 working days of receipt and keep the appellant informed of the progress in evaluating the appeal until it is closed./此申诉应在收到 ASCP的申诉决定后的 10 个日历日内提出。若未能在此时间内提交，将导致良好棉花不审查该申诉。良好棉花应在收到申诉后的 10 个工作日内确认，并在评估申诉直至结案的过程中持续向提出上诉者通报进展情况。

7. Multi-Site Certification/多场所认证

7.1 Scope/范围

The Multi-Site requirements may apply to any organization wishing to enter 2 or more sites to the Better Cotton Chain of Custody Standard. There are two options for organizations in this position:/多场所要求适用于任何希望进入 2 个或更多场所的组织，以达到良好棉花监管链标准。这类组织有两种选择：


- Single Chain of Custody Audit and Certificate for organizations with Multiple Sites/Units;/多个场所/单位的组织的单一监管链审核和证书；
- Multi-site Certification for Independent Sites Managed by a Central Function./中心功能管理的独立场所的多场所认证。

7.2 Single Chain of Custody Audit and Certificate for organizations with

Multiple Sites/Units/多个场所/单位的组织的单一监管链审核和证书

In some circumstances an organization may own additional sites at more than one location. These sites can be covered by a single audit report and certificate if all the following criteria are met:/在某些情况下，组织可能拥有位于不同地点的多场所。如果满足以下所有标准，这些场所可以通过一份审核报告和证书进行覆盖：

- All site(s) shall operate under the same ownership;/所有场所都必须在同一所有权下运营；
- Only the site that will be listed as the certificate holder shall be responsible for purchasing and sales of Better Cotton;/只有作为证书持有者列出的场所才负责购买和销售良好棉花；
- All site(s) shall have the same management system as the organization that will be listed as the certificate holder;/所有场所必须拥有与将被列为证书持有者的组织相同管理体系；
- The additional site(s) shall not process and/or handle Better Cotton independently of the organization that will be listed as the certificate holder;/附加场所不得独立于将被列为证书持有者的组织加工和/或处理良好棉花；

- The additional site(s) shall only supply each other and not have separate customers or suppliers;/附加场所只能相互供应，不能拥有独立的组织或供应商；
